

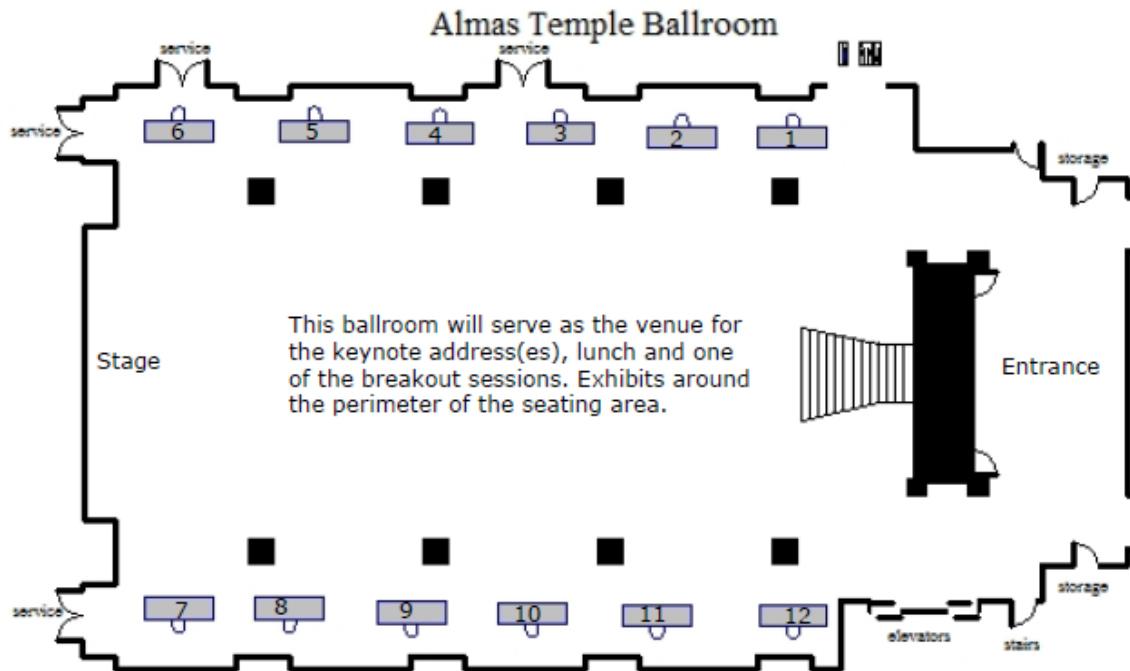


Sponsor Prospectus
10th National GIS in Transit Conference
September 6-8, 2017
Hamilton Crowne Plaza Hotel & Almas Conference Center
Washington, DC

The National Center for Transit Research, Urban and Regional Information Systems Association and the Transportation Research Board are jointly sponsoring the 10th National GIS in Transit Conference, on September 6-8, 2017, in Washington, DC. The conference takes place every two years and was 'bursting at the seams' in 2015. To address requests from both attendees and the vendor community, this year we're expanding into the Almas Conference Center (adjacent to the Hamilton Crowne Plaza) in order to accommodate more participants and incorporate an exhibition.

The twelve exhibit spaces will be placed around the perimeter of the Almas Ballroom which is where the keynote address(es) will be delivered, where lunch will be served, and where one of the three conference breakout sessions will be situated. There will be ample opportunity to connect with the attendees and take part in the conference. Each exhibit space will include a table and chair, access to the conference wifi and a basic power outlet.

Gold Conference Sponsor Package:
